Health System Barriers

- Step 1:**

After each group has prioritised their barriers, gather as a workshop to identify whether any of these barriers are structural or system-wide challenges that impact most or all communities. These challenges often stem from issues at the healthcare system level, such as a shortage of healthcare workers or limited access to healthcare data.
- Step 2:**

Use the “Health System Barriers Prompt Card: Why” from Workshop 1 to help you identify if there are health system barriers.
- Step 3:**

If you identify any health system barriers, write them in the boxes on the left side and tick which category of health system barrier it is. ***If there are no health system barriers, leave this poster blank.***
